

## I AM NOT A SERIAL KILLER COMPETITION – WIN YOUR SHORT STORY PRESENTED BY AUTHOR DAN WELLS & A MONSTER FEST PRIZE PACK

### Terms and Conditions

1. The Promotion is a game of skill and chance plays no part in determining the winner. The Promoter is Monster Pictures (ACN 149 779 242) of 741 Rathdowne Street Carlton North VIC Australia 3054.
2. Promotion commences on 1 September 2016 at 09:30am AEST and ends 15 September 2016 at 11:59pm AEST (**Promotional Period**). One (1) prize winner (the **Winner**) will receive the following:
  - i. Their short story read on video by author Dan Wells to be hosted on the Monster Pictures website and on the DVD & Blu-ray release of the film – Maximum value of \$500.
  - ii. A double pass to see I AM NOT A SERIAL KILLER theatrically in Sydney, Melbourne or Brisbane – Maximum value of \$40.
  - iii. A pass to the Swinburne University Media and Communications Monster Academy (the 2-day industry symposium section of Monster Fest) on November 23<sup>rd</sup> & 24<sup>th</sup> 2016 – Maximum value of \$200.
  - iv. Five (5) x Monster Pictures DVD – Maximum value of \$100

  - a. write a short story intended for a YA (Young Adult) audience with the theme of funeral stories in 1000 to 1250 words and

    - i. include the short story in the body of the email, not as an attachment;
    - ii. feature the subject header 'I Am Not a Serial Killer Competition';
    - iii. include your contact details: name and telephone number;
    - iv. write 'I agree to the terms & conditions of the promotion'.
4. This promotion is a game of skill and entries will be judged on originality, creativity, literary merit and suitability in accordance with clauses 5 and clause 17 (if applicable).
5. Judging will be conducted by Monster Pictures (ACN 149 779 242) of 741 Rathdowne Street Carlton North VIC Australia 3054 in association with Dan Wells on 28 September 2016 at 10:00am AEST. All valid entries received by the Promoter during the Promotion Period will be judged.
6. There will be a total of one (1) winner.
7. The result of the judgement is final and no correspondence will be entered into.
8. The winner will be contacted by email on 29 September 2016. The name and short story of the winner will be read aloud by Dan Wells on video and published at <https://www.monsterfest.com.au> on 29 September 2016.
9. Participation in the Promotion is deemed acceptance of these Terms and Conditions. These Terms and Conditions must be read together with the terms provided on the Promotion entry page. In the event of any conflict, the terms on the entry page supersede any conflicting terms in these Terms and Conditions.
10. The time of entry will in each case be the time the online entry is received by the Promoter's database. The Promoter accepts no responsibility for any late, lost or misdirected entries due to technical disruptions or for any other reason.

The Promoter reserves the right to rejudge in the event of a winner not being an Eligible Entrant, not having complied with these Terms and Conditions or not being able to be contacted by the Promoter after the Promoter having made reasonable efforts to do so. If a second judgement is necessary, it will be conducted by Monster Pictures (ACN 149 779 242) of 741 Rathdowne Street Carlton North VIC Australia 3054 on 5 October 2016 at 11:00am AEST, subject to any written direction given under applicable law. Any winner determined in accordance with this clause 17 will be notified by email on October 5th and the name and short story of the winner will be read aloud by Dan Wells on video and published at <https://www.monsterfest.com.au> on 5 October 2016.
